## Great Ideas

COLDMD™

If you bought Cold MD, a legal settlement could pay you up to \$10 per bottle you purchased.

A Settlement has been proposed in a class action lawsuit with Iomedix Cold International SRL ("Defendant") involving Cold MD dietary supplement ("ColdMD")

**WHAT IS THE LAWSUIT ABOUT?**

The lawsuit claims that Defendant made misleading or false statements about Cold MD. Defendant denies any wrongdoing or illegal conduct but has agreed to settle the case.

**WHAT COLD MD PRODUCTS ARE INCLUDED?**

The Settlement includes only the Cold MD dietary supplement which was packaged as "Cold MD" and had the words, "Dietary Supplement" printed on the lower right corner of the front of the box it was sold in.

**AM I A MEMBER OF THE CLASS?**

You are a member of the class if you purchased the Cold MD product listed above in the United States or any of its Territories from March 26, 2004 through May 29, 2009.

**WHAT DOES THE SETTLEMENT PROVIDE?**

Money is available for eligible people who purchased the Cold MD product for personal use between March 26, 2004 and May 29, 2009. The Settlement also prohibits Defendant from advertising the Cold MD product in a false or deceptive manner. The Settlement does not mean that Defendant did anything wrong, and the Court has not decided that Defendant did anything wrong.

**HOW MUCH MONEY CAN I GET BACK?**

Each Class Member who provides a valid receipt or credit card statement showing that they purchased the Product will be sent a check in the amount of \$10.00 for each bottle purchased during the Class Period. Each Class Member who does not have a valid receipt or credit card statement showing that they purchased the Product, but who submits the Declaration included in the Claim Form saying that they purchased the Product, will be sent a check in the amount of \$5.00 for each bottle purchased during the Class period, up to a maximum of six bottles if the Claim Form is sent via U.S. mail, and up to three bottles if submitted online via the settlement Website. All Class Members who send valid Claim Forms also may receive one bottle of Cold MD homeopathic formula for each bottle of Product purchased during the Class Period.

**WHAT ARE MY OPTIONS?**

- File a Claim. You must remain in the Class to file a claim. You will be bound by the Court's rulings, but you can object to the Settlement. Claim Forms must be signed and postmarked, or signed and submitted through the settlement Website, [www.ColdMDSettlement.com](http://www.ColdMDSettlement.com) by **September 22, 2009**. By remaining in the Class, you will release claims against the Defendants as outlined in the Settlement Agreement, available at the settlement Website. Please read the Release carefully, as it affects your legal rights.

- Exclude yourself and keep your right to sue the Defendants. Your written request for exclusion must be postmarked by **August 24, 2009**.

- Object to the Settlement and/or appear in Court, only if you remain in the Class. You may hire your own attorney for these purposes. Your written request must be postmarked by **August 24, 2009**. Details on how to file a Claim, exclude yourself, object or appear in the case are available at the Website, address or number listed below. The Court will decide whether to approve the Settlement at the Fairness Hearing on **October 20, 2009 at 9:00 a.m.**

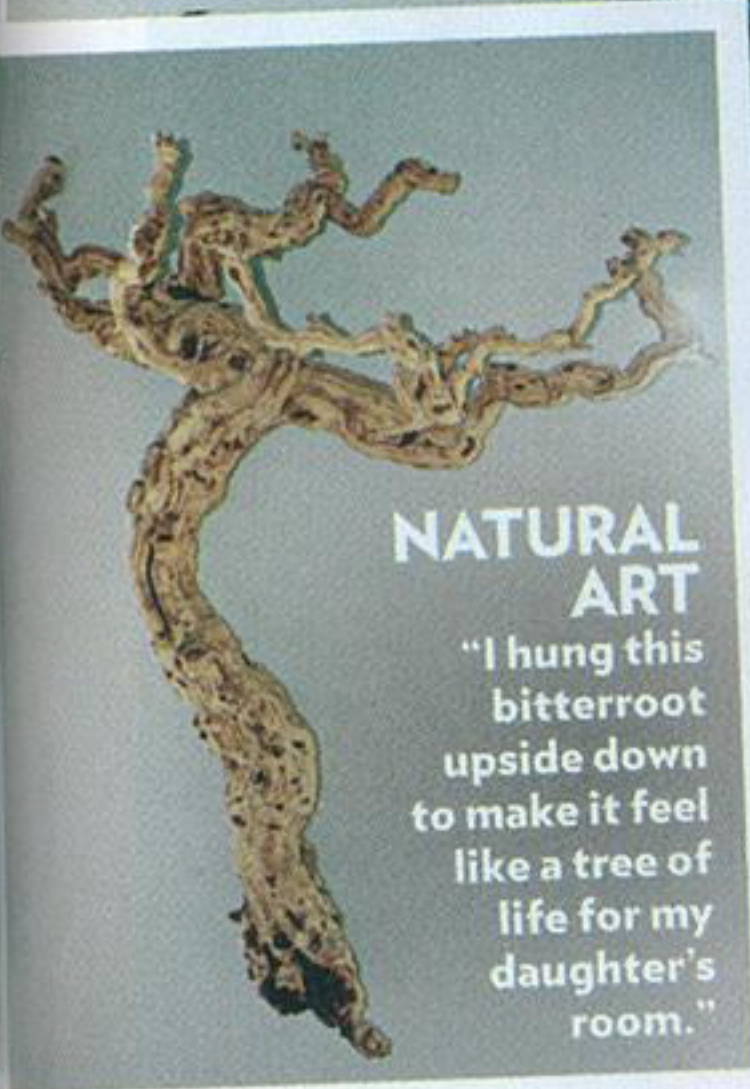

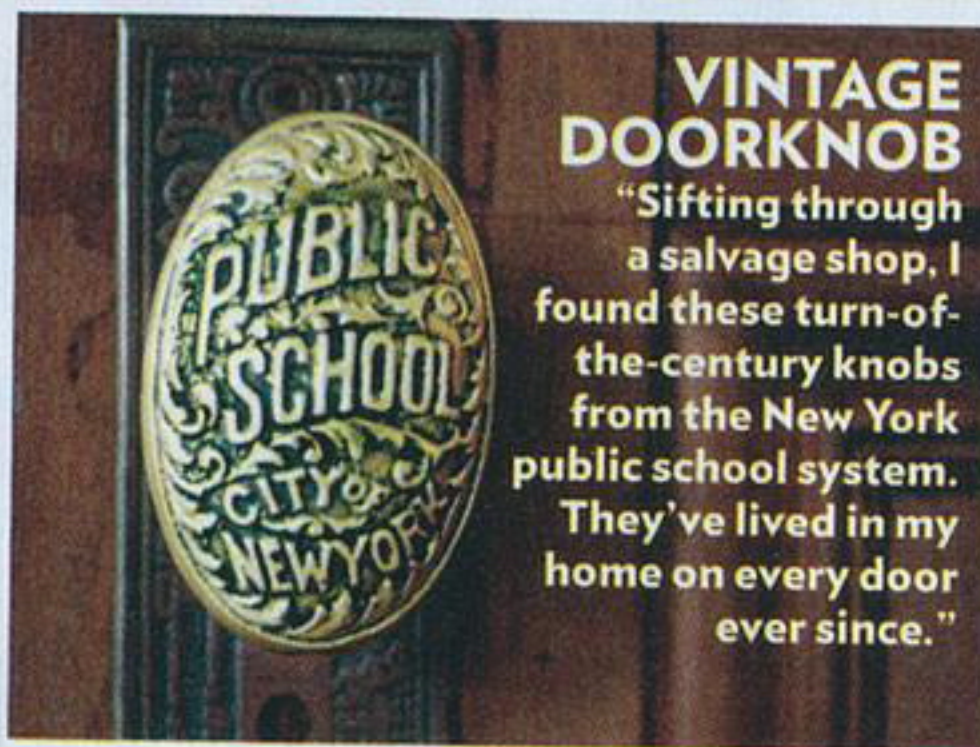

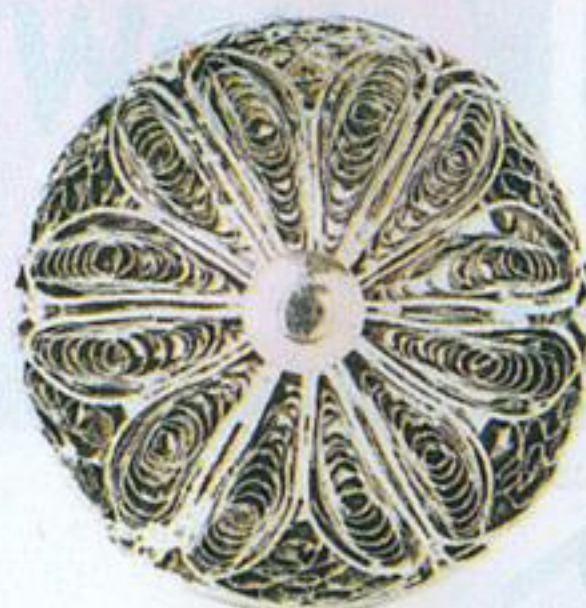
